

Up to \$3000 is potentially available for projects, depending on the works proposed and other applications received.

Funding will not be allocated towards projects that have already commenced or are completed.





Amount sought must be matched dollar for dollar by the applicant.

It is expected that all applications will be considered by Council's Heritage Advisor and Council's Strategic Planner in November 2021. The recommendations of Council's Heritage Advisor will be reported to Council for adoption. Letters notifying applicants of the outcome of their application will be issued after the Council meeting.

The total amount of funding available is limited so it may not be possible to fund all eligible projects.
