A statutory declaration under the Statutory Declarations Act 1959 may be made before—

1. a person who is currently licensed or registered under a law to practise in one of the following occupations:

Chiropractor	Nurse	Psychologist
Dentist	Optometrist	Trade marks attorney
Legal practitioner	Patent attorney	Veterinary surgeon
Medical practitioner	Pharmacist	Physiotherapist
2. a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner (however described); or
3. a person who is in the following list:
 - ❖ Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
 - ❖ Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the Consular Fees Act 1955)
 - ❖ Bailiff
 - ❖ Bank officer with 5 or more continuous years of service
 - ❖ Building society officer with 5 or more years of continuous service
 - ❖ Chief executive officer of a Commonwealth court
 - ❖ Clerk of a court
 - ❖ Commissioner for Affidavits
 - ❖ Commissioner for Declarations
 - ❖ Credit union officer with 5 or more years of continuous service
 - ❖ Employee of the Australian Trade Commission who is:
 - in a country or place outside Australia; and
 - authorised under paragraph 3 (d) of the Consular Fees Act 1955; and
 - exercising his or her function in that place
 - ❖ Employee of the Commonwealth who is:
 - in a country or place outside Australia; and
 - authorised under paragraph 3 (c) of the Consular Fees Act 1955; and
 - exercising his or her function in that place
 - ❖ Fellow of the National Tax Accountants' Association
 - ❖ Finance company officer with 5 or more years of continuous service
 - ❖ Holder of a statutory office not specified in another item in this list
 - ❖ Judge of a court
 - ❖ Justice of the Peace
 - ❖ Magistrate
 - ❖ Marriage celebrant registered under Subdivision C of Division 1 of Part IV of the Marriage Act 1961
 - ❖ Master of a court
 - ❖ Member of Chartered Secretaries Australia
 - ❖ Member of Engineers Australia, other than at the grade of student
 - ❖ Member of the Association of Taxation and Management Accountants
 - ❖ Member of the Australasian Institute of Mining and Metallurgy
 - ❖ Member of the Australian Defence Force who is:
 - an officer; or
 - a non-commissioned officer within the meaning of the Defence Force Discipline Act 1982 with 5 or more years of continuous service; or
 - a warrant officer within the meaning of that Act
 - ❖ Member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants
 - ❖ Member of:
 - the Parliament of the Commonwealth; or
 - the Parliament of a State; or
 - a Territory legislature; or
 - a local government authority of a State or Territory
 - ❖ Minister of religion registered under Subdivision A of Division 1 of Part IV of the Marriage Act 1961
 - ❖ Notary public
 - ❖ Permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public
 - ❖ Permanent employee of:
 - the Commonwealth or a Commonwealth authority; or
 - a State or Territory or a State or Territory authority; or
 - a local government authority;with 5 or more years of continuous service who is not specified in another item in this list
 - ❖ Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made
 - ❖ Police officer
 - ❖ Registrar, or Deputy Registrar, of a court
 - ❖ Senior Executive Service employee of:
 - the Commonwealth or a Commonwealth authority; or
 - a State or Territory or a State or Territory authority
 - ❖ Sheriff
 - ❖ Sheriff's officer
 - ❖ Teacher employed on a full-time basis at a school or tertiary education institution
